Single author: Note (Rigger 1999, 55-56) Include the author's last name, publication date, and the page number referenced. In Chicago Author-Date, you put a "," between the date and page numbers referenced.

Sufficiently Argued Below. There is no bright-line rule for determining whether an argument has been sufficiently raised below, and courts often attempt to explain sufficiency with generalities, noting that a party 'must press, not merely intimate, an argument,' Kelly v. Foti, 77 F.3d 819, 823 (5th Cir. 1996), or that an argument cannot be raised in a 'perfunctory and underdeveloped' manner.
